

- The Company's shares have been suspended for trading by the BSE Ltd due to certain non-compliances with the listing agreement. The Company has obtained in-principle approval from BSE Limited and duly submitted all the documents and paid re-instatement fees to BSE Limited as mentioned therein and is awaiting for a notice of revocation. However, to suffice the requirement of in-principle approval obtained from BSE Ltd to revoke the suspension in trading of equity shares, the promoters shareholding will further be locked in upto 30/09/2016 for compliance purpose.
- The Figures for the last quarter ended March 31, are the balancing figures between the audited figures in respect of the full financial year and the published year-to-date figures upto the third quarter of the relevant financial year.
- Figures for the previous periods have been regrouped / restated, wherever necessary.





