Independent Auditor's Review Report on Unaudited Quarterly Financial Results of the Company.

To the Board of Directors of Technojet Consultants Limited

1. We have reviewed the accompanying statement of unaudited financial results of **Technojet Consultants Limited** ('the Company') for the quarter ended December 31, 2022 and year to date results for the period from April 1, 2022 to December 31, 2022, together with the notes thereon (referred to as 'the Statement', which we have initialled for identification), being submitted by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India ("the SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
